
Wildflower Days Festival Wildflowers & Wildlife . . . Nowhere but the Wildflower Center!

It's that time again! The Wildflower Center's annual Wildflower Days Festival is just around the corner, Saturday and Sunday, April 12 and 13. This year's theme is "Wildflowers & Wildlife." Lectures, authors, and educational activities will focus on the complex interdependence and interactions between native plants and indigenous wildlife.

Our keynote speaker this year is environmentalist and activist Robert F. Kennedy Jr., who will give a talk entitled "A Contract With Our Future," which addresses our responsibility as caretakers of the environment for future generations.

Attorney Robert F. Kennedy Jr.'s reputation as a resolute defender of the environment stems from a litany of successful legal actions. He has prosecuted governments and companies for polluting the Hudson River and

Long Island Sound, won settlements for the Hudson Riverkeeper, and sued sewage treatment plants to force compliance with the Clean Water Act. Hudson Riverkeeper John Cronin describes Mr. Kennedy as "a pioneer as an attorney in the area of municipal and government responsibility for environmental problems."







not adapted to the soils and climatic extremes of their region.

Aesthetically, we gain extended seasonal color, new design options, and a regional "sense of place," instead of the homogeneous look of traditional landscapes. And this is possible with naturalistic, semi-formal, or formal garden design styles. For many, this may be one of the most compelling reasons to begin incorporating regional, propagated native plants into planned landscapes.

Whatever the reason, this "movement" is rapidly becoming the way of the future, the *immediate* future. Because it has been embraced by the mainstream, it is no longer the cause of the historic native plant enthusiast. It gives me great pride to watch as this ecologically sound and regionally appropriate (and beautiful) land ethic continues to become a permanent and positive change in the way we all live with the land. I thank *you* for being the agents of this change, as will future generations. Keep up the good work!
